



## Standard Terms & Conditions

1. Thank you for your business. Please note my standard script revision & re-voicing policy: Easy and speedy correction of any mispronounced words.
2. Script Revisions: To encourage only '**Final**' scripts, One script revision and two re-takes (re-voicings) representing less than 10% of the voiced script, \*within 48 hours of WAV VOICE file delivery\* are included at no additional charge.  
Subsequent revisions/re-voicings will each cost \$55.
3. To encourage only '**Final**' scripts, script revisions that require a full re-voicing of a script will be subject to an additional basic studio fee. (\$250 USD).
4. My fee is based on recording, editing and delivering your script's number of words and its category of media 'usage' (plus, when applicable, PayPal's 4.5% processing fee).
5. **License Term:** Use of the recording on **non-paid channels** (website, company YouTube, regular social posts, email, in-store/event screens, internal training) is licensed for **12 months from delivery**. **Renew/upgrade anytime**—or choose the **Freedom Licensing Option** for lifetime non-paid use. Should you choose later to upgrade to paid placement usage on any media platform, you agree to negotiate a new 'usage fee' for such usage with my agents at Ta-Da! Voiceworks (647) 351-3530
6. **Freedom Option** Client is granted a non-transferable, worldwide, **perpetual license** to use the recording on all **non-paid web channels** including the client's website, company YouTube uploads, regular (unboosted) social posts, email newsletters, in-store or event screens, and internal/training content. **HST is included** in the quoted fee. **Paid advertising placements (e.g., boosted social, YouTube pre-roll, TV/radio, programmatic/CTV) are not included** and require a separate usage license to be negotiated with my agent, Ta-Da! Voiceworks..
7. Client specifically agrees not to sell or transfer ownership to all or part of any of the original files recording the performance of the voice actor, including any underlying data, to any third party for purposes of using the files for artificial intelligence (AI), such as text to speech, or speech to speech uses without the voice actor's knowledge and consent. Client agrees to use good faith efforts to prevent any files of recordings or performances, or the underlying data, stored in digital format containing voice actor's voice or likeness from unauthorized access by third parties, and if such files are stored in "the cloud", client agrees to utilize services that offer safeguards through encryption or other "up-to-date" technological means from unauthorized third party access.
8. Delivery (WAV file via WeTransfer) will be within 24-hours of receiving your final script.

9. Please remit full payment within 10 calendar days of your WAV file's delivery via WISE or PAYPAL or Canadian Bank eTransfer.
